## **2022 MOTORSHOW CONTEST RULES**

### **1. Organisation**

The Contest (hereafter referred to as the « the Contest ») is organised within the framework of the 2022 Motorshow by FEBIAC NPO (hereafter referred to as « the Organiser»), with registered office established at 1200 Brussels, Boulevard de la Woluwe 46, box 6.

### **2. Conditions for participation**

2.1. The Contest is exclusively accessible for

- (i) any natural person who has reached the full age of 18, has his legal place of residence in Belgium during the entire period of the Contest and who participates in the Organiser's online survey, namely the «99e Motorshow Contest»,
- (ii) all companies subject to VAT, which have their registered office in Belgium during the entire period of the Contest and a legal representative of which participates in the Organiser's online survey, namely the «99e Motorshow Contest ».

2.2. Participation in the Contest is prohibited for

- (i) members of the Organiser,
- (ii) persons who have a direct or indirect legal tie with the Organiser or with any other company that collaborates in the organisation of the Contest and for
- (iii) persons who have a direct tie with the above-mentioned persons (such as blood relatives in ascending or descending line, spouses, cohabitants, brothers, and sisters of the members of the aforementioned legal persons or natural persons).

2.3. Only one participation per physical person or company/TVA number is permitted. Multiple participations by one and the same Participant by means of different electronic addresses or identities, or in any other manner whatsoever, shall result in that Participant's exclusion.

### **3. Accessibility and duration**

The Contest is accessible via the following URL <https://www.askoto.be/en/contest> that is communicated in a newsletter, on the official website and via the social media of the Motorshow.

The Contest begins on 14/01/22 at 9 a.m. GMT and runs through 13/02/2022 at 12 a.m. GMT.

Participation in the Contest is free of charge.

#### **4. Terms of the Contest**

##### **4.1. One can participate only:**

- by surfing to <https://www.askoto.be/en/contest> ;
- by answering the questions in the "Contest 99e Motorshow" ;
- by answering the Contest question plus the elimination question;
- subject to provision of a valid e-mail address, last name, first name and telephone number; for companies, the VAT number and title must also be indicated; incomplete or wrongly filled-in registration of the participant his/her entry will not be taken into account in the selection of the winners.
- by submitting a signed quotation of a not-yet registered car, motorcycle or van (light commercial vehicle). The date of the signed quotation must fall within the period from 14 through 31 January 2022. The quotation must be made by one of the official dealers of FEBIAC affiliated members. The official dealers of FEBIAC affiliated members are listed on our members' website (the list of our members is available at the end of the rules). You will be asked for this quotation when FEBIAC contacts you as a potential winner.;

The winners in each vehicle category will be those who:

1. have answered the first question correctly or, if there is no correct answer in their category, whose answer is closest to the correct answer (1st selection criterion);
2. Have met the first selection criterion and give the correct answer to the subsidiary question or, in the absence of a correct answer in their category, whose answer to the subsidiary question is closest to the correct answer;
3. In the event of a tie, the date on which the above offer is received by the Organiser will determine the order of winners, with priority given to the offer received first.

The competition is conducted under the supervision of the firm Labranche (bailiffs), located in 1000 Brussels, Chaussée de la Hulpe 110 (T. 02.546.16.40, F. 02.514.06.00, [info@labranche.info](mailto:info@labranche.info)). At the end of the Contest, the bailiff shall select 3 winners from among the entry forms received before 13/02/2022 at 12 a.m. GMT

4.2. The winners shall be determined by 7/3/2022 at the latest. The results of the competition will be communicated exclusively by e-mail, to the address indicated by the participant at the time of registration, no later than 15/3/2022, at midnight.

Winners must claim their prizes by 23/4/2022 at the latest.

In the absence of any reaction within this period, the winners will lose the right to their prize. Prizes claimed will be delivered to the email address provided by the Organiser to the winners by 23/6/2022. Unclaimed prizes will not be redistributed to other participants.

4.3. Non-winners will not receive any message or other communication notifying them that they have not won a prize.

4.4. The Organiser reserves the right to publish or not the names and surnames of the winners and the list of prizes won on the website [www.autosalon.be](http://www.autosalon.be) without any right for the winners other than taking possession of their prize. Given the nature of the competition and the terms and conditions of the competition, the Organiser has a legitimate interest in making the

winner's identity public without the winner's right to privacy being significantly impacted.

4.5. Any violation of these rules, fraud or attempted fraud (identity theft, various entries under false identities, submission of a false offer to purchase, use of forgeries, use of robots, etc.) or any other abuse will result in the exclusion from the competition of the participant involved.

## **5. Prizes**

5.1. There are 3 winners, one per category (see below). The winner will be awarded a voucher for the purchase - valid until 15 09 2022 - of the vehicle covered by the offer submitted and issued by one of our affiliate member dealers. Each voucher has a maximum value of €9,999 including VAT for a private individual (corresponding to €8,263.64 excluding VAT for a company), unless the cost of the vehicle purchased (including all charges) is less than this amount. In the latter case, the voucher will be of the same value as the vehicle purchased. The vouchers are allocated as follows:

- 1 voucher in the "AUTO" category (cars);
- 1 voucher in the "MOTO" category (motorcycles);
- 1 voucher in the "VAN" category (light commercial vehicles);

5.2. The awarded prizes are neither collectible nor exchangeable. If the value of the purchase exceeds the value of the prize, the winner shall pay the difference. The winners may, after receiving their vouchers, have the quotation adjusted by their dealer. However, the chosen vehicle must be purchased from the dealer who made the original quotation.

5.3. The Organiser reserves the right to change the Competition prizes at its sole discretion, although always for prizes of equal value. The Organiser does not provide any implicit or explicit guarantee with regard to the type, the quality or the suitability of the prize for a particular purpose.

5.4 The terms and conditions for withdrawing the amount of the voucher will be specified in the letter accompanying the voucher. In order to withdraw the amount of the voucher, the winner must send an e-mail or a letter to FEBIAC indicating the reason for sending the letter ("withdrawal of the amount of the voucher for the salon auto 2022 competition"), the bank account number to which the amount of the prize must be paid, proof of residence in Belgium during the competition and a copy of both sides of the winner's identity card. For companies, the ECB identification number must be included in the letter sent to FEBIAC.

5.6. The voucher expires on 15 September 2022 at midnight.

5.7. A voucher handover ceremony will be organised (at a later date) with the winner and the vehicle covered by the offer submitted to FEBIAC.

5.7 In case of cancellation of the sale of the vehicle purchased from one of the official dealers of FEBIAC's affiliated members, the amount of the voucher must be reimbursed to FEBIAC by the winner concerned.

## **6. Liability of the Organiser**

6.1 The Organiser cannot under any circumstances be held responsible for direct or indirect

damage suffered by a participant and caused by a technical failure, a malfunction of the Internet network or of the computer equipment used (due to a bug, virus, etc.) by the participant or by any other anomaly linked to the specific limitations of the Internet, to the use or exploitation of computer equipment.

6.2. The Organiser reserves the right to modify the organisation, extend, suspend or terminate the Competition at any time and without prior notice, in the event of force majeure or any other exceptional event beyond its control, without being held liable.

6.3. Except in the case of gross error or intent on their part, neither the Organiser, nor its personnel, nor the third parties who are called upon within the framework of this Contest may be held responsible for any damage of whatever kind that should derive from the organisation of this Contest, including the participation in the Contest, the designation of the winners and the awarding of the prize. They also reject any potential liability for possible changes, suspensions or cancellations such as referred to in the preceding point.

6.4. The Organiser is not liable for incorrect or incomplete information given by Participants, such as an invalid e-mail or wrong or unknown telephone details.

6.5. The Organiser reserves the right, at its sole discretion, to suspend or withdraw the Competition at any time if required to do so by law or for compelling self-regulatory reasons, without any right to compensation or indemnity to participants.

## **7. Claim or dispute**

7.1. Any dispute or complaint regarding the Salon 2022 Competition must be addressed by standard letter to FEBIAC NPO, the organising company of the Salon 2022, whose registered office is located at 1200 Brussels, Boulevard de la Woluwe 46, box 6. A lack of response can in no way be considered as an acceptance by the Organiser of what has been written.

## **8. Privacy**

The Participant's data, as furnished within the framework of this Contest, are processed by FEBIAC NPO with registered office established at 1200 Brussels, Boulevard de la Woluwe 46, box 6. The data collection and processing are performed by FEBIAC in accordance with the applicable EU and Belgian laws on the protection of personal data.

FEBIAC collects and processes the data anonymously for research and for statistical purposes relating to the 2022 Motorshow.

FEBIAC uses the personal data of the contest participants in order to ensure the proper performance of the contract concluded with you in accordance with Article 6.1.b of the GDPR (e.g. the possibility to contact the winners and award them their prizes).

If the Participant gave specifically his consent on the participation form that the Organiser may use the data for marketing purposes (including receiving newsletters about the products and services of the Organiser), the Organiser may keep and use the Participant's data for the purpose of this objective.

However, each participant has the right, at any time, to withdraw his or her authorisation in order to avoid receiving advertising messages from the Organiser in the future. To do so, he/she may consult FEBIAC's personal data protection charter, available on [AskOTO.BE](https://askoto.be)

## **9. Acceptance**

9.1. Participation in the Contest entails full acceptance of the Contest Rules and the decisions taken thereunder by the Organiser.

9.2. The Contest Rules can also be consulted during the online survey. Moreover, if desired, each Participant can send a written request for a copy of them to [salon@febiac.be](mailto:salon@febiac.be).

## **10. Law and court**

These Contest Rules, as well as the conduct of the Contest itself, are governed by Belgian law. In case of dispute, the courts of appeal and tribunals of Brussels have exclusive jurisdiction.

## **11. Miscellaneous**

The partial or complete invalidity or lapsing of one of the provisions of the Contest Rules shall not affect the validity of the other provisions of the Contest Rules.
